**--Annual Renewal--**

Per new instructions from National Headquarters, all cadets that are re-enrolling need to complete the new NSCADM001 form. This does require a new medical form that needs to be signed by a **doctor**. The new form will be e-mailed to cadets and parents when it is time to renew. Please complete the form and upload it to your parent portal. Submission your re-enrollment fee to the Admin Officer.

Annual dues are \$175 per Cadet. Each additional sibling there is a discount
